Sir,

I am directed to refer to this Office letter of even no. dated 23/08/2017, on the above mentioned subject and to say that all out efforts to finalise the revision of pension of pre-2016 CDA pensioners in co-ordination with the O/o CCA may be taken up seriously and to meet the target by 15/09/2017.

2. The work of revision of pension of pre-2016 CDA pensioners may be carried out with the help of the following records/ documents as per DOT letter No. 7-1/2017/TA-I/Pre-2016/4705 to 4732 dated 29/08/2017 addressed to all Pr. CsCA/CsCA (copy enclosed):-

- i) Service Book, wherever available
- ii) Pension File - Calculation Sheet, Scale of Pay
- iii) Pay Bill Record
- iv) Last Pay drawn/Pay Scale with reference to last designation at the time of retirement
- v) Any official document showing authentic record, available with the pensioners in case of non-availability of any of the mentioned documents mentioned at (i) to (iv) above.

3. For this purpose, the Head of the Circle will form a Committee comprising GMs of HR and Finance Wing of the Circle to speed up the revision of pension of pre-2016 CDA pensioners.

4. As already instructed in the letter dated 23/08/2017, the work relating to revision of pension of pre-2016 CDA pensioners may be carried out and sent to CCAs urgently. The information regarding the number of pension revision cases sent to CCA as asked for vide this office letter dated 20/06/2017 may be uploaded in google report without fail.
