
NFTE Circle body represented by Circle Secretary Vide letter under reference requested to consider the transfer of GR "C" Officials back to TS Circle on the following grounds

- Completion of 58 / 59 years of Age ,
- Officials suffering from Medical problems ,
- Spouse Cases

CS NFTE further stated that Officials are eligible for being considered for Transfer under the provisions (Section A, 6(e)) of Transfer policy dated 07.05.2008.

Where as the GR "C" Officials were transferred from TS Circle Hyderabad to A.P Circle Vijayawada invoking the Bifurcation norms under special dispensation by extending the privilege of Soft Tenure.

Since the Bifurcation norms do not envisage the Transfer of officials till the completion of Three years period (Soft tenure period), the matter is referred to Corporate office for further guidance on the subject matter .

Sub :- Consideration of request transfers to Hyderabad who have completed 58/59 years- Requested.

In continuation of this union letter dated 16-01-2018 it is to submit that some officials in our circle office who came from Hyderabad on bifurcation have completed 58/59 years of service. In BSNL transfer policy dated 7-5-2008 and 24-11-2014 under section A of 6(e) left over two service to superannuation cases shall be considered to their choices place. But in bifurcation the same clause is not available. Some of the officials came to circle office on bifurcation suffering with some medical problems, spouse cases, completed 58/59 years of service. The circle office is not in a position to sort out/consider their cases keeping in view of the rigid bifurcation rules.

Therefore it is requested to sought clarification from corporate office to consider these cases by referring our recognised union letters. In clarification clearly mentioned that in normal cases 58/59 cases are being considered as per the transfer policy.
